## Minutes of Executive Committee meeting 17<sup>th</sup> Jan 2017. Held at The Fourcroft Hotel, Tenby.

1.) Apologies for absence: Richard Wingfield, Trevor Hallett, Dan Warder (Chairman, Tenby Chamber of Trade).

## 2.) Minutes of September's meeting:

8 a2.) Allen's View. Correction. Should read "No gates will be made or installed" The minutes were then accepted as a true record.

#### 3.) Matters arising from November's meeting:

- 3 (9.1) Eric Bradforth plaque. The plaque is now ready. Harry will contact the family to arrange the unveiling. Mayor Cllr Laurence Blackhall will be in attendance.
- 3 (9.2) Heritage Awards. Chair is recruiting a judging panel prior to contacting owners of nominated properties. Ideal panel candidates are: Naomi Tydeman, Murray John, Rob Scourfield and Norman Hughes.

- 7.2) St Catherine's Island. Application for change of use to a visitor attraction. A reference is made to an existing mains sewer connection, which does not in fact exist. It was agreed to support a temporary solution.
- 7.3) Rear of Cross Park, New Hedges. Millbay Homes intend to build 41 homes. A full application is expected imminently.
- 7.4) The Manor House, Penally. The plan for a new orangery was discussed.
- 7.5) Brynhir development. Tudor and Harry will meet representatives of the opposition group at the site on 25<sup>th</sup> Jan at 2pm.

## 8.) Reports:

#### a.) Allen's View.

- a.1) Tree Surgeon will remove Leylandii. Stumps will be utilised for bench supports and sculpture. Trevor has been sanding one of the benches. The shed urgently requires maintenance. Vehicle access could be improved. The bench on the northern view could be raised in height. There are many small jobs that could be done. In most cases the financial costs are prohibitive.
- a.2) Yorkshire Building Society have pledged £100.
- a.3) Tenby Rotary are still interested in donating, though nothing has been forthcoming to date.

## b.) Tenby Regeneration Trust.

b.1) Chair attended a large meeting along with representatives of other local groups. A remodelling of Battery Gardens was proposed, with a £20,000 price tag. It was suggested that we could support the scheme by refreshing the shrubbery nearby.

A large cinema screen was proposed for the De Valence Pavilion, at a cost of £10,000. Pembrokeshire County Council may consider assistance with funding the project.

- b.2) Tenby Wi-Fi network now includes the indoor market.
- b.3) Tenby Harbour. A watching brief is being kept. Nothing new to report.
- b.4) Tenby Master Plan. Chair will attend next meeting, hosted by Mayor Blackhall.
- b.5) Tenby Characterisation Proposal by Richard Wingfield. Jacqui circulated copies. The proposal was discussed, along with the practicalities of using official maps.
